The number of Directors may be increased or decreased by amendment of these Bylaws, provided that no decrease shall reduce the total number of Directors to less than three Directors or shorten the term of any incumbent Director, and no increase shall expand the number of Directors to greater than nine Directors; provided, however, that the number of self-perpetuating director positions shall, at all times, be one less than the number of CCSC-elected director positions, it being the intent that a majority of the Board of Directors be CCSC-elected directorships. If the number of directors is hereafter changed, any newly created directorships or decrease in directorships shall be so apportioned among the classes as to make all classes as nearly equal in number as possible.
