Emergency Services - Southwest provides food and financial assistance to residents of southwest Houston. Financial assistance is targeted to help with a family's utilities. Services were provided to 16,906 people in crisis during 2014.

Back to School - provides disadvantaged students with grade-appropriate school supplies, new clothing and gently used clothing at the start of each school year. A total of 6,518 students received assistance in 2014.
